

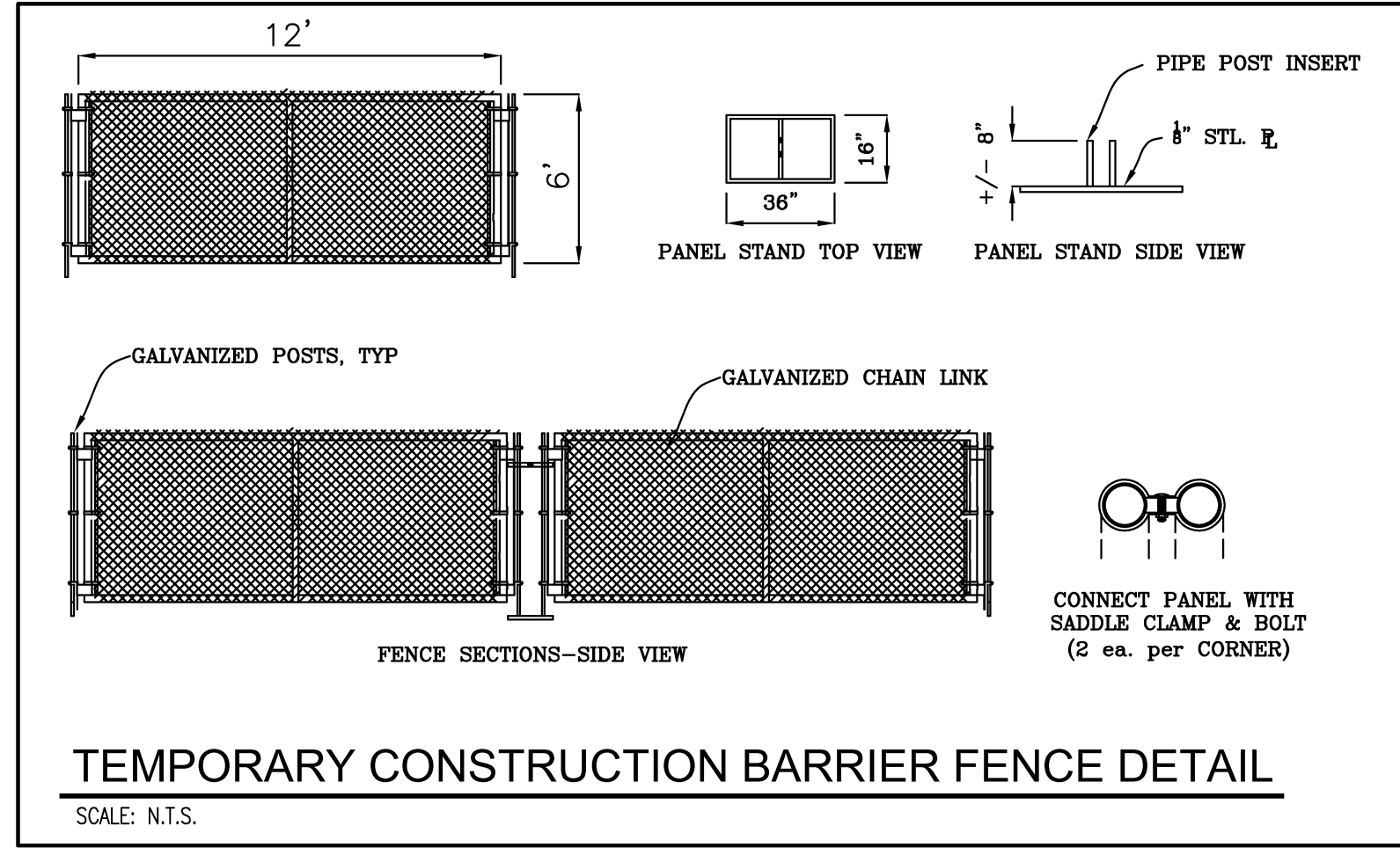

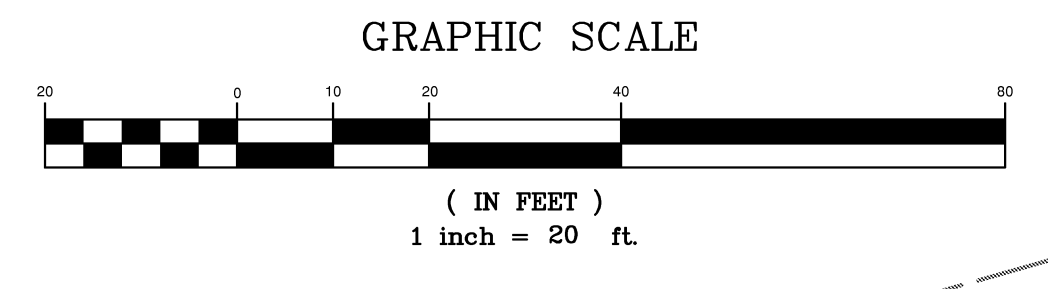
DEMOLITION NOTES

- CONTRACTOR TO REMOVE ALL EXISTING TREES, SHRUBS, BRUSH, ASPHALT, CONCRETE, SIDEWALKS, TRAFFIC SIGNS, VEGETATION, DIRT, GRAVEL, ROCK, LIGHT POLES AND ETC. WITHIN THE DEMO AREA DEPICTED HEREON OR IN CONFLICT WITH NEW IMPROVEMENTS. ALL SAID MATERIALS REMOVED BY THE CONTRACTOR NOT INDICATED TO BE SALVAGED SHALL BECOME THE PROPERTY OF THE CONTRACTOR, UNLESS OTHERWISE DIRECTED BY THE PROJECT MANAGER OR OWNER AND SHALL BE REMOVED FROM THE PROPERTY IN A LEGAL AND APPROVED MANNER AT NO ADDITIONAL COST TO THE OWNER(S).
- ALL EXISTING UTILITIES SERVING FACILITIES THAT ARE TO REMAIN IN-PLACE DURING CONSTRUCTION MUST REMAIN OPERATIONAL THROUGHOUT CONSTRUCTION. THOSE UTILITIES THAT ARE LOCATED WITHIN THE DEMOLITION AREAS MUST BE PROTECTED AND MAINTAINED.
- ALL EXISTING UTILITIES TO FACILITIES TO REMAIN WHICH CROSS THE DEMOLITION AREA MAY REQUIRE RELOCATING OR REMOVAL.
- ANY EXISTING IMPROVEMENTS DAMAGED DURING CONSTRUCTION SHALL BE REPLACED BY THE CONTRACTOR AT CONTRACTORS EXPENSE WITH NEW TO MATCH EXISTING. ANY EXISTING ITEMS WHICH INTERFERE WITH CONSTRUCTION SHALL BE REMOVED AT THE CONTRACTOR'S EXPENSE WHETHER INDICATED HEREON OR NOT.

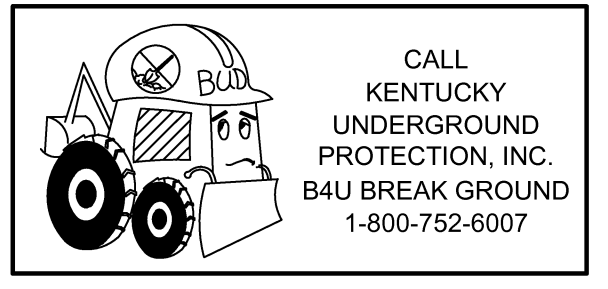
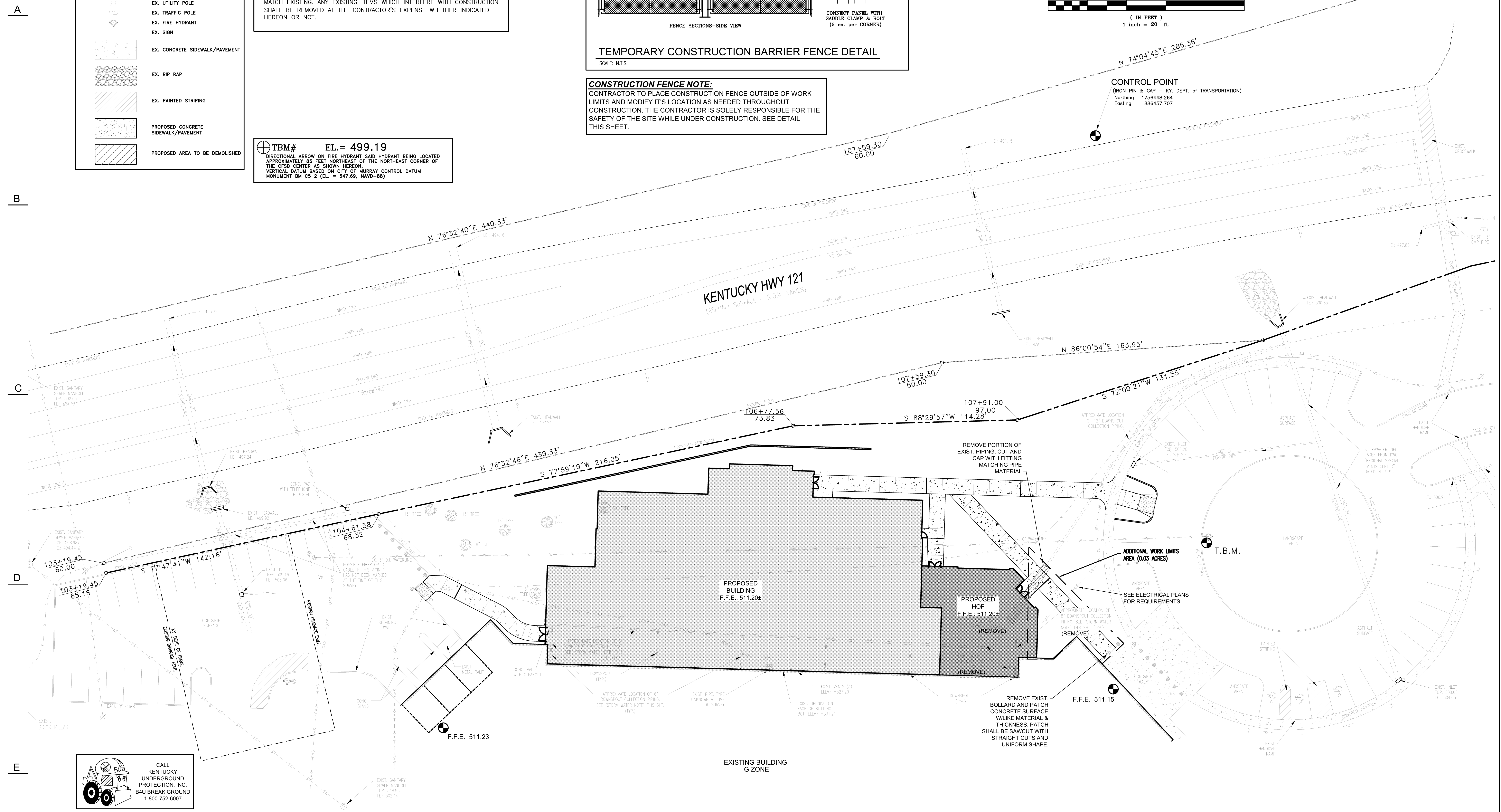
